INTRODUCTION

Hawaiian Airlines, Inc., a Hawaiian Corporation (the "Sponsor" or the "Employer") has established a Health Reimbursement Arrangement (the "Plan" or the "HRA") for the benefit of certain Flight Attendants who are eligible to participate in the Plan pursuant to the terms set forth herein (the "Participants"). The purpose of the Plan is to reimburse Participants for certain medical expenses and health insurance premiums which are not otherwise reimbursed. The Plan is intended to qualify as a self-insured medical reimbursement plan for purposes of Sections 105 and 106 of the Internal Revenue Code, as amended (the "Code"), as well as a health reimbursement arrangement as defined in IRS Notice 2002-45. The Plan also is intended to be exempt from certain requirements and mandates of the Patient Protection and Affordable Care Act (the "ACA") as a separate "retiree-only" plan pursuant to ERISA Section 732(a) and IRC Section 9831(a)(2).

The material provisions of the Plan, as of the Effective Date, are set forth in this Summary Plan Description and Plan Document (referred to herein as either "SPD" or the "Plan", as appropriate). The Plan may be amended, modified, and changed by the Sponsor to reflect the terms of any future agreement negotiated between the Sponsor and the Association of Flight Attendants – CWA ("AFA"), the union that represented the Participants prior to their retirement from the Sponsor, and memorialized in a Letter of Agreement ("LOA") or any future Collective Bargaining Agreement ("CBA").

Note that capitalized terms used in this SPD are defined the first time they are used or as they are set forth in the Plan Information Appendix at the end of this SPD. Also, please note that occasionally the words "you," "your" and "my" are used for ease of reading and understanding and refer to the Participant.

PART I GENERAL INFORMATION ABOUT THE PLAN

Q-1. What is the purpose of the Plan?

The purpose of the Plan is to reimburse Participants for Eligible Medical Expenses (as defined in Q-6) incurred after the Enrollment Date, which are not otherwise reimbursed by any other plan or program. Reimbursements for Eligible Medical Expenses paid by the Plan generally are excludable from the Participant's taxable income.

Q-2. Who can participate in the Plan?

Flight Attendants who separate from the Sponsor with more than thirty Years of Service (as defined in the Plan Information Appendix) are eligible to participate in the Plan and become a Participant. Flight Attendants who have been terminated for cause are not eligible, despite having more than thirty Years of Service.

Q-3. Can my dependents participate in the Plan?

You can be reimbursed for Eligible Medical Expenses that are incurred by your Eligible Dependents after you become a Participant.

Your Dependents may include your legal spouse, your dependent children (up to a certain age) and any other individual who is your dependent for federal income tax purposes. You are required to provide proof of dependent status upon request by the Plan Administrator (or its designee). Failure to provide such proof may result in a delay in or denial of benefits provided under the Plan. In addition, the Plan will allow reimbursement of Eligible Medical Expenses for a child of yours (as defined by applicable state law) in accordance with a Qualified Medical Child Support Order ("QMCSO") to the extent the QMCSO does not require coverage not otherwise offered under this Plan. The Plan Administrator will make a determination as to whether the order is a QMCSO in accordance with the Plan's QMCSO procedures. The Plan Administrator will notify both you and the affected child once a determination has been made. You may request a copy of the Plan's QMCSO procedures, free of charge, by contacting the Plan Administrator at the address listed in the Plan Information Appendix.

Q-4. When do I actually become a Participant in the Plan?

Flight Attendants whose last day of employment with the Employer was or is between January 1, 2017 and April 2, 2025 and have more than thirty Years of Service as a flight attendant on their last day of employment, shall be deemed to become eligible to be a Participant in the Plan on the later of the Effective Date or last day of employment.

Q-5. How does the Plan work?

The Sponsor will provide a Benefit Credit to the HRA Account of a Participant based on the Participant's Years of Service. The Benefit Credit amounts are shown in the table below:

Years of Service (YOS)	Benefit Credit
30-35 YOS	\$10,000
35+ - 40 YOS	\$20,000
40+ YOS	\$30,000

The Benefit Credit amount in a Participant's HRA Account will be reduced from time to time by the amount of any Eligible Medical Expenses for which the Participant is reimbursed under the Plan. At any time, the Participant may receive reimbursement for Eligible Medical Expenses up to the amount in his or her HRA Account. Participants are not allowed to make any contributions to their HRA Accounts.

An HRA Account is merely a bookkeeping or notional account maintained by the Employer in the name of and for the benefit of each Participant to track the payment of that Participant's Eligible Medical Expenses. The HRA Account is not a funded account nor does it bear interest or accrue earnings of any kind. All reimbursements for or benefits paid under the Plan are paid entirely from the Employer's general assets.

Q-6. What is an "Eligible Medical Expense"?

An Eligible Medical Expense is an expense incurred by you or any Eligible Dependent for medical care, as that term is defined in Code Section 213(d) (generally, expenses related to the diagnosis, care, mitigation, treatment or prevention of disease). Some common examples of Eligible Medical Expenses include:

- Medications (in reasonable quantities);
 - o Medications prescribed by a doctor or insulin.
 - This Plan reimburses expenses for covered Part D prescription drugs only to the extent of the Catastrophic Coverage Reimbursement described in the Plan Information Appendix.
- Dental expenses;
- Dermatology;
- Physical therapy;
- Contact lenses or glasses used to correct a vision impairment;
- Birth control pills;
- Chiropractor treatments;
- Hearing aids;
- Wheelchairs; and
- Individual insurance policy premiums including: major medical individual insurance premiums, stand-alone dental and/or vision premiums, Medicare Advantage premiums, Medicare Parts A, B, and D premiums, and Medicare supplemental insurance premiums.

Some examples of common items that are not Eligible Medical Expenses include:

- Baby-sitting and childcare;
- Long-term care services;

- Cosmetic surgery or similar procedures (unless the surgery is necessary to correct a deformity arising from a congenital abnormality, accident or disfiguring disease);
- Funeral and burial expenses;
- Household and domestic help;
- Massage therapy;
- Custodial care:
- Health club or fitness program dues (unless specific requirements are satisfied); and
- Cosmetics, toiletries, toothpaste, etc.

For more information about what items may or may not be Eligible Medical Expenses, consult IRS Publication 502, "Medical and Dental Expenses," under the headings "What Medical Expenses Are Includible" and "What Expenses Are Not Includible." (Be careful in relying on this Publication, however, as it is specifically designed to address what medical expenses are deductible on Form 1040, Schedule A, not what is reimbursable under a health reimbursement arrangement.) If you need more information regarding whether an expense is an Eligible Medical Expense under the Plan, contact the Third-Party Administrator as provided in the Plan Information Appendix. The Plan Administrator (and its delegates) solely determine what is an Eligible Medical Expense. In no event shall any benefits under this Plan be provided in the form of cash or any other taxable or nontaxable benefit other than reimbursement for Eligible Medical Expenses.

Only Eligible Medical Expenses incurred while you are a Participant in the Plan may be reimbursed from your HRA Account. Similarly, only Eligible Medical Expenses incurred while your Eligible Dependent is a Participant in the Plan may be reimbursed from his or her HRA Account. Eligible Medical Expenses are "incurred" when the medical care is provided, not when you or your Eligible Dependent are billed, charged or pay for the expense. Health insurance premiums are incurred for the coverage period to which they apply. An expense that has been paid but not incurred (e.g. pre-payment to a physician or for premiums) will not be reimbursed until the services or treatment giving rise to the expense has been provided.

The following expenses may not be reimbursed from an HRA Account:

- expenses incurred for qualified long-term care services;
- expenses incurred for covered Part D prescription drugs;
- expenses incurred *prior to the date* that you became a Participant in the HRA;
- expenses incurred after the date that you cease to be a Participant in the HRA;
- expenses that have been reimbursed by another plan or for which you plan to seek reimbursement under another health plan; and
- any other expenses specifically identified as excluded in the Plan Information Appendix.

Q-7. When do I cease participation in the Plan?

You will cease being a Participant in the Plan on the earliest of:

- the date that your Benefit Credit in your HRA account is \$0;
- your date of death, except for any rights your Eligible Dependents may have to continue in the Plan; or

- the termination of your eligibility under the Plan (with respect to an Eligible Dependent Spouse, the date he or she dies or is divorced from the Participant, and when any other person ceases to meet the definition of Eligible Dependent, both subject to COBRA rights);
- termination of the Plan itself as may be agreed to in any LOA or CBA entered into between the Sponsor and AFA.

Q-8. What happens if I do not use all of the credits allocated to my HRA Account during the Plan Year?

If you do not use all of the amounts credited to your HRA Account during a Plan Year, those amounts will be carried over to subsequent Plan Years, until the HRA Account is exhausted or you and your Eligible Dependents cease to participate as described in Q-7 and Q-11.

Q-9. How do I receive reimbursement under the Plan?

The Sponsor has appointed a Third-Party Administrator (TPA) to process claims and reimbursements from your HRA account. The TPA may automate claims processing via a reimbursement card or other procedure. Alternatively you can complete a reimbursement form and mail it to the TPA as provided in the Plan Information Appendix, along with a supporting documentation such as a copy of your insurance premium bill or an "explanation of benefits" or "EOB," or an itemized statement that can demonstrate that the claim is for an Eligible Medical Expense. You can obtain a reimbursement form from the TPA identified in the Plan Information Appendix. Your claim is deemed filed when it is received by the TPA.

If your claim for reimbursement is approved, you will be provided reimbursement as soon as reasonably possible following the determination. Claims are paid in the order in which they are received by the TPA.

The TPA shall determine the method or mode of reimbursement payments, including whether by direct deposit, written check, or otherwise.

The TPA may establish an auto reimbursement process for the payment of certain health insurance premiums. Auto reimbursements shall not be considered to be claims for benefits and shall not be subject to the claims procedures in Q-10. In establishing and operating any auto reimbursement process, the Claims Submission Agent may establish a process to remove and/or prevent duplicate reimbursements. Removal of duplicate reimbursements and following procedures to prevent duplicate reimbursements shall also not be considered to be claims for benefits and shall not be subject to the claims procedures in Q-10.

Q-10. What happens if my claim for benefits is denied?

If your claim for reimbursement is wholly or partially denied, you will be notified in writing within 30 days after the TPA receives your claim. If the TPA determines that an extension of this time period is necessary due to matters beyond the control of the Plan, the TPA will notify you within the initial 30-day period that an extension of up to an additional 15 days will be required. If the extension is necessary because you failed to provide sufficient information to allow the claim to be decided, you will be notified and you will have at least 45 days to provide the additional information. The notice of denial will contain:

- the reason(s) for the denial and the Plan provisions on which the denial is based;
- a description of any additional information necessary for you to perfect your claim, why the information is necessary, and your time limit for submitting the information;
- a description of the Plan's appeal procedures and the time limits applicable to such procedures; and
- a description of your right to request all documentation relevant to your claim.

If your request for reimbursement under the Plan is denied in whole or in part and you do not agree with the decision of the TPA, you may file a written appeal. You should file your appeal with the Plan Administrator at the address provided in the Plan Information Appendix no later than 180 days after receipt of the denial notice. You should submit all information identified in the notice of denial, as necessary, to perfect your claim and any additional information that you believe would support your claim.

You will be notified in writing of the decision on appeal no later than 60 days after the Plan Administrator receives your request for appeal. The notice will contain the same type of information provided in the first notice of denial provided by the TPA.

Note that you cannot file suit in federal court until you have exhausted these appeals procedures.

Any claim or action that is filed in a court or other tribunal against or with respect to the Plan and/or the Plan Administrator must be brought within the following timeframes:

- For any claim or action relating to HRA Account benefits, the claim or action must be brought within 18 months of the date of the denied appeal.
- For all other claims (including eligibility claims), the claim or action must be brought within two years of the date when you know or should know of the actions or events that gave rise to your claim.

Note that the claims procedures and time frames described above are intended to comply with the requirements of the U.S. Department of Labor's Claims Procedures as now existing or as the same be modified or amended at any time or from time to time (the "DOL Procedures"). The claims procedures for this Plan shall be interpreted and applied so as to comply with the DOL Procedures in effect at the time the decision, denial, or other event complained of occurred.

Q-11 What happens if I die?

If an Eligible Flight Attendant dies while a Participant in the Plan without an Eligible Dependent, the decedent's HRA Account shall terminate and be forfeited immediately upon death. Any claims for reimbursement for Eligible Medical Expenses incurred by a Participant prior to the date of death may be submitted by duly authorized representatives of the Participant's estate (or by an Eligible Dependent, as described below) provided such claims are submitted within 180 days of the deceased Participant's death.

If the Eligible Flight Attendant dies while a Participant in the Plan with an Eligible Dependent his or her HRA Account shall transfer to the Eligible Dependent who shall then become a "Participant" until he or she dies or ceases to be an Eligible Dependent. Any balance in the HRA Account when all Eligible Dependents have ceased to participate is forfeited.

Q-12. Are my benefits taxable?

The Plan is intended to meet certain requirements of existing federal tax laws, under which the benefits you receive under the Plan generally are not taxable to you. However, the Employer cannot guarantee the tax treatment to any given Participant, as individual circumstances may produce different results. If there is any doubt, you should consult your own tax advisor.

Q-13. What happens if I receive an overpayment under the Plan or a reimbursement is made in error from my HRA Account?

If it is later determined that you or your Eligible Dependent received an overpayment or a payment was made in error (e.g., you were reimbursed from your HRA Account for an expense that is later paid by another medical plan), you or your Eligible Dependent will be required to refund the overpayment or erroneous reimbursement to the Employer.

If you do not refund the overpayment or erroneous payment, the Employer reserves the right to offset future reimbursements equal to the overpayment or erroneous payment or, if that is not feasible, to withhold such funds from any amounts due to you from the Employer. If all other attempts to recoup the overpayment/erroneous payment are unsuccessful, the Plan Administrator may treat the overpayment as a bad debt, which may have tax implications for you.

Q-14. How long will the Plan remain in effect?

The Sponsor has established the Plan pursuant to a CBA between it and AFA that was ratified on April 3, 2020. Eligible Flight Attendants shall be those flight attendants with the requisite Years of Service and whose retirement date from the Sponsor is between January 1, 2017 and April 2, 2025 (the "Current Participants"). The Sponsor and AFA intend that the Plan shall remain in effect until the HRA Accounts of all Current Participants and their Eligible Dependents are exhausted. In the event that the Sponsor notifies AFA that the number and size of the remaining HRA Accounts makes continuing the Plan unduly burdensome, AFA agrees to enter into negotiations with the Sponsor to address such claim.

Q-15. How does the Plan interact with other medical plans?

For the purposes of reimbursement or payment under this Plan, a claim shall be deemed to be an Eligible Medical Expense only to the extent that such expense, in addition to satisfying the requirements of Code Section 213(d), has not been reimbursed and is not reimbursable by any other source or plan.

Q-16. Who do I contact if I have questions about the Plan?

If you have any questions about the Plan, you should contact the Third-Party Administrator or the Plan Administrator. Contact information for the Third-Party Administrator and the Plan Administrator is provided in the Plan Information Appendix.

Q-17. Are there any fees that I have to pay to participate in the Plan?

The Sponsor is responsible for paying the fees associated with this Plan except in the following circumstances:

• HRA Accounts with balances under \$100 that have not had any claim reimbursement activity for six months will be assessed a monthly administration fee of \$6 per month, starting on the first day of the seventh month and the first day

- of each month thereafter. This fee will be deducted from the Credit Balance of the Participant's HRA Account.
- HRA Accounts with balances over \$100 that have not had any claim reimbursement activity for sixty months will be assessed a monthly administration fee of \$12 per month, starting on the first day of the sixty-first month and the first day of each month thereafter. This fee will be deducted from the Credit Balance of the Participant's HRA Account.

PART II ERISA RIGHTS

This Plan is an employee welfare benefit plan as defined in the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). ERISA provides that you, as a Plan Participant, will be entitled to:

Receive Information about Your Plan and Benefits

- Examine, without charge, at the Plan Administrator's office and at other specified locations, such as worksites and union halls, all documents governing the Plan, including insurance contracts, collective bargaining agreements, and a copy of the latest annual report (Form 5500 series) filed by the Plan with the U.S. Department of Labor and available at the Public Disclosure Room of the Employee Benefits Security Administration.
- Obtain, upon written request to the Plan Administrator, copies of all documents governing
 the operation of the Plan, including insurance contracts and collective bargaining
 agreements, and copies of the latest annual report (Form 5500 series) and updated
 Summary Plan Description. The Plan Administrator may apply a reasonable charge for the
 copies.
- Receive a summary of the Plan's annual financial report. The Plan Administrator is required by law to furnish each participant with a copy of this summary annual report.

Prudent Actions by Plan Fiduciaries

In addition to creating rights for Plan participants, ERISA imposes duties upon the people who are responsible for the operation of the employee benefit plan. The people who operate your Plan, called "fiduciaries" of the Plan, have a duty to do so prudently and in the interest of the Plan participants and beneficiaries. No one, including your employer, your union, or any other person, may fire you or otherwise discriminate against you in any way to prevent you from obtaining a welfare benefit from the Plan, or from exercising your rights under ERISA.

Enforcement of Your Rights

If your claim for a welfare benefit under an ERISA-covered plan is denied in whole or in part, you must receive a written explanation of the reason for the denial. You have the right to have the Plan review and reconsider your claim. Under ERISA, there are steps you can take to enforce the above rights. For instance, if you request materials from the Plan and do not receive them within 30 days, you may file suit in a federal court. In such a case, the court may require the Plan Administrator to provide the materials and pay you up to \$110 a day until you receive the materials, unless the materials were not sent because of reasons beyond the control of the Administrator. If you have a claim for benefits that is denied or ignored in whole or in part, you may file suit in a state or federal court. In addition, if you disagree with the Plan's decision or lack thereof concerning the qualified status of a domestic relations order or a medical child support order, you may file suit in federal court. If it should happen that plan fiduciaries misuse the Plan's money or if you are discriminated against for asserting your rights, you may seek assistance from the U.S. Department of Labor, or you may file suit in a federal court. The court will decide who should pay court costs and legal fees. If you are successful, the court may order the person you have sued to pay these costs and fees. If you lose, the court may order you to pay these costs and fees (e.g., if it finds your claim is frivolous).

Assistance with Your Questions

If you have any questions about the Plan, you should contact the Plan Administrator. If you have any questions about this statement or about your rights under ERISA, or if you need assistance obtaining documents from the Plan Administrator, you should contact the nearest office of the U.S. Department of Labor, Employee Benefits Security Administration listed in your telephone directory, or the Division of Technical Assistance and Inquiries, Employee Benefits Security Administration, U.S. Department of Labor, 200 Constitution Ave., N.W., Washington, D.C., 20210. You may also obtain certain publications about your rights and responsibilities under ERISA by calling the publications hotline of the Employee Benefits Security Administration.

PART III LEGAL NOTICES

Health Insurance Portability and Accountability Act

THIS NOTICE DESCRIBES HOW MEDICAL INFORMATION ABOUT YOU MAY BE USED AND DISCLOSED AND HOW YOU CAN GET ACCESS TO THIS INFORMATION. PLEASE REVIEW IT CAREFULLY

Section 1. Introduction

The Plan is dedicated to maintaining the privacy of your health information. The Plan is required by law to take reasonable steps to ensure the privacy of your personally identifiable health information or "Protected Health Information" ("PHI") and to inform you about:

- the Plan's uses and disclosures of PHI;
- your privacy rights with respect to your PHI;
- the Plan's duties with respect to your PHI;
- your right to file a complaint with the Plan and to the Secretary of the U.S. Department of Health and Human Services; and
- the person or office to contact for further information about the Plan's privacy practices.

The term "Protected Health Information" or "PHI" includes all individually identifiable health information transmitted or maintained by the Plan, regardless of form (oral, written, electronic). The Plan is required by law to maintain the privacy of PHI and to provide individuals with notice of its legal duties and privacy practices.

The Plan is required to comply with the terms of this notice. However, the Plan reserves the right to change its privacy practices and to apply the changes to all PHI received or maintained by the Plan, including PHI received or maintained prior to the change. If a privacy practice described in this Notice is materially changed, a revised version of this notice will be provided to all individuals then covered under the Plan for whom the Plan still maintains PHI. The revised notice will be provided by mail or by another method permitted by law.

Any revised version of this notice will be distributed within 60 days of the effective date of any material change to the uses or disclosures, the individual's rights, the duties of the Plan or other privacy practices stated in this notice.

Please note that the Plan Sponsor obtains summary PHI, enrollment and disenrollment, termination of coverage and specific appeals information from the Plan. Most records containing your PHI are created and retained by the Third-Party Administrator for the Plan. In the event that the Plan Sponsor receives PHI, the Plan has been amended to require that the Plan Sponsor only use and disclose PHI received from the Plan for plan administrative purposes or as otherwise permitted by federal law. This notice only applies to Protected Health Information or PHI as defined in the applicable HIPAA privacy rules.

Section 2. Notice of PHI Uses and Disclosures

Except as otherwise indicated in this notice, uses and disclosures will be made only with your written authorization, subject to your right to revoke such authorization.

A. Required PHI Uses and Disclosures

Upon your request, the Plan is required to give you access to certain PHI in order to inspect and copy it.

Use and disclosure of your PHI may be required by the Secretary of the Department of Health and Human Services to investigate or determine the Plan's compliance with the privacy regulations.

The Plan also will disclose PHI to the Plan Sponsor for plan administrative purposes or as otherwise permitted by law. The Plan Sponsor has amended its plan documents to protect your PHI as required by federal law.

The Plan contracts with business associates for certain services related to the Plan. PHI about you may be disclosed to the business associates so that they can perform contracted services. To protect your PHI, the business associate is required to appropriately safeguard the protected health information. The following categories describe the different ways in which the Plan and its business associates may use and disclose your PHI.

B. Uses and disclosures to carry out treatment, payment and health care operations

The Plan and its business associates will use PHI without your consent, authorization, or opportunity to agree or object, to carry out treatment, payment and health care operations.

Treatment is the provision, coordination or management of health care and related services. It also includes but is not limited to consultations and referrals between one or more of your providers. For example, the Plan may disclose to a treating cardiologist the name of your treating physician so that the cardiologist may ask for your lab results from the treating physician.

Payment includes but is not limited to actions to make coverage determinations and payment (including billing, claims management, subrogation, plan reimbursement, reviews for medical necessity and appropriateness of care and utilization review and pre-authorizations). For example, the Plan may tell a doctor whether you are eligible for coverage or what percentage of the bill will be paid by the Plan.

Health care operations include but are not limited to quality assessment and improvement, reviewing competence or qualifications of health care professionals, underwriting, premium rating and other insurance activities relating to creating or renewing insurance contracts. It also includes disease management, case management, conducting or arranging for medical review, legal services and auditing functions including fraud and abuse compliance programs, business planning and development, business management and general administrative activities. For example, the Plan may use information about your claims to refer you to a disease management program, project future benefit costs or audit the accuracy of its claims processing functions.

C. Authorized uses and disclosures

You must provide the Plan with your written authorization for the types of uses and disclosures that are not identified by this notice or permitted or required by applicable law.

Any authorization you provide to the Plan regarding the use and disclosure of your health information may be revoked at any time **in writing**. After you revoke your authorization, the Plan will no longer use or disclose your health information for the reasons described in the authorization, except for the two situations noted below:

- The Plan has taken action in reliance on your authorization before it received your written revocation; or
- You were required to give the Plan your authorization as a condition of obtaining coverage.

D. Uses and disclosures for which consent, authorization or opportunity to object is not required

Use and disclosure of your PHI is allowed without your consent, authorization or request under the following circumstances:

- When required by law.
- When permitted for purposes of public health activities, including when necessary to report
 product defects, to permit product recalls and to conduct post-marketing surveillance. PHI
 may also be used or disclosed if you have been exposed to a communicable disease or are
 at risk of spreading a disease or condition, if authorized by law.
- When authorized by law to report information about abuse, neglect or domestic violence to public authorities if there exists a reasonable belief that you may be a victim of abuse, neglect or domestic violence. In such case, the Plan will promptly inform you that such a disclosure has been or will be made unless that notice would cause a risk of serious harm. For the purpose of reporting child abuse or neglect, it is not necessary to inform the minor that such a disclosure has been or will be made. Disclosure may generally be made to the minor's parents or other representatives although there may be circumstances under federal or state law when the parents or other representatives may not be given access to the minor's PHI.
- To a public health oversight agency for oversight activities authorized by law. This includes uses or disclosures in civil, administrative or criminal investigations; inspections; licensure or disciplinary actions (for example, to investigate complaints against providers); and other activities necessary for appropriate oversight of government benefit programs (for example, to investigate Medicare or Medicaid fraud).
- When required for judicial or administrative proceedings. For example, your PHI may be disclosed in response to a subpoena or discovery request provided certain conditions are met. One of those conditions is that satisfactory assurances must be given to the Plan that the requesting party has made a good faith attempt to provide written notice to you, and the notice provided sufficient information about the proceeding to permit you to raise an objection and no objections were raised or were resolved in favor of disclosure by the court or tribunal.
- For law enforcement purposes, including to report certain types of wounds or for the purpose of identifying or locating a suspect, fugitive, material witness or missing person. The Plan may also disclose PHI when disclosing information about an individual who is or is suspected to be a victim of a crime, but only if the individual agrees to the disclosure

or the covered entity is unable to obtain the individual's agreement because of emergency circumstances. Furthermore, the law enforcement official must represent that the information is not intended to be used against the individual, the immediate law enforcement activity would be materially and adversely affected by waiting to obtain the individual's agreement and disclosure is in the best interest of the individual as determined by the exercise of the Plan's best judgment.

- When required to be given to a coroner or medical examiner for the purpose of identifying a deceased person, determining a cause of death or other duties as authorized by law. Also, disclosure is permitted to funeral directors, consistent with applicable law, as necessary to carry out their duties with respect to the decedent.
- For research, subject to conditions.
- When consistent with applicable law and standards of ethical conduct if the Plan, in good faith, believes the use or disclosure is necessary to prevent or lessen a serious and imminent threat to the health or safety of a person or the public and the disclosure is to a person reasonably able to prevent or lessen the threat, including the target of the threat
- When authorized by and to the extent necessary to comply with workers' compensation or other similar programs established by law.

Notwithstanding the above, and to the extent provided in applicable law, the Plan shall not use or disclose your PHI that is classified as genetic information for purposes of any underwriting activity.

Section 3. Rights of Individuals

A. Right to Request Restrictions on PHI Uses and Disclosures

You may request that the Plan restrict uses and disclosures of your PHI to carry out treatment, payment or health care operations, or restrict uses and disclosures to family members, relatives, friends or other persons identified by you who are involved in your care or payment for your care. However, the Plan is not required to agree to your request.

With respect to a health care provider, you have a right to request that a health care provider restrict disclosure of your PHI and not disclose such PHI and related claim information to the Plan, if the PHI pertains solely to a health care item or service for which you or another person on your behalf has paid the health care provider and you have not requested reimbursement from the Plan.

The Plan will accommodate reasonable requests to receive communications of PHI by alternative means or at alternative locations as required by law. You or your personal representative will be required to complete a form to request restrictions on uses and disclosures of your PHI. Such requests should be made to the Plan at the address provided at the end of this Notice specifying the requested method of contact or the location where you wish to be contacted.

B. Right to Inspect and Copy PHI

With certain exceptions described below, you have the right to inspect and copy your PHI if it is part of a "Designated Record Set" or "DRS." The DRS is the group of records maintained by or on behalf of the Plan contained in the enrollment, payment, claims adjudication, and case or

medical management record systems of the Plan, and any other records which are used by the Plan to make decisions about individuals. This right does not extend to psychotherapy notes, information gathered for certain civil, criminal or administrative proceedings, and information maintained by the Sponsor that duplicates information maintained by a Plan business associate in its DRS.

The Plan must provide you with access to the PHI contained in a DRS in the form and format requested by you. However, if the PHI is not readily producible in such form or format, it must be produced in a readable hard copy form or such other form as agreed to by the Plan and you. Further, if the PHI is maintained in an electronic DRS, you may request an electronic copy of the PHI in an electronic form or format. However, if the PHI is not readily producible in a specific electronic form and format requested by you, the Plan and you must agree on the electronic form or format in which it will be produced.

If you request a copy of your PHI contained in a DRS, the Plan may charge you a reasonable, cost-based fee for the expense of copying, mailing and/or other supplies associated with your request. To inspect and obtain a copy of your PHI that is part of a DRS, you must submit your request in writing.

If you exercise your right to access your PHI, the Plan will respond to your request within 30 days, subject to a one-time extension of an additional 30 days. In the case of an extension, the Plan must provide you with a written explanation for the delay and the date by which it will respond to your request.

The Plan may deny your request to inspect and copy your PHI in certain limited situations. If you are denied access to your PHI, you will be notified in writing. The notice of denial will include the basis for the denial, and a description of any appeal rights you may have and the right to file a complaint with the Plan or with the Department of Health and Human Services. If the Plan does not maintain the PHI that you are seeking but knows where it is maintained, the Plan will notify you of where to direct your request.

C. Right to Amend PHI

If you believe that your PHI in a DRS is incorrect or incomplete, you may request that the Plan amend the PHI. Any such request must be made in writing and must include a reason that supports your requested amendment. The Plan must respond to your request within 60 days. If the Plan is not able to respond within this 60-day period, it may have a one-time 30-day extension by providing you with a written explanation for the delay and the date by which it will respond to your request.

In limited situations, the Plan may deny your request to amend your PHI. For example, the Plan may deny your request if (1) the PHI was not created by the Plan (except where you are unable to request an amendment from the person or entity that created the PHI because the person or entity is no longer available); (2) the Plan determines the information to be accurate or complete; (3) the information is not part of the DRS; or (4) the information is not part of the information which you would be permitted to inspect and copy, such as psychotherapy notes. If your request is denied, you will be notified in writing. The notice of denial will include the basis for the denial, a description of your right to submit a statement of disagreement and a description of your right to file a complaint with the Plan or with the Department of Health and Human Services.

D. Right to Receive an Accounting of PHI Disclosures

You have the right to request an accounting of certain types of disclosures of your PHI made by the Plan during a specified period of time. You do not have the right to request an accounting of all disclosures of your PHI. For example, you do not have the right to receive an accounting of (1) disclosures for purposes of Treatment, Payment or Health Care Operations; (2) disclosures to you or your personal representative regarding your own PHI; (3) disclosures pursuant to an authorization; or (4) disclosures made more than six years ago (or the inception of the Plan, whichever is later).

Your request must indicate the time period for which you are seeking the accounting, such as a single month, six months or two calendar years. This time period may not be longer than six [6] years and may not include any disclosures of PHI made before the inception of the Plan. The Plan must respond to your request within 60 days. If the Plan is not able to respond within this 60-day period, it may have a one-time 30-day extension by providing you with a written explanation for the delay and the date by which it will respond to your request.

The Plan will provide the first accounting you request in any 12-month period free of charge. The Plan may impose a reasonable, cost-based fee for each subsequent accounting request within the 12-month period. The Plan will notify you in advance of the fee and provide you with an opportunity to withdraw or modify your request.

E. The Right to Receive a Paper Copy of This Notice Upon Request

To obtain a paper copy of this Notice at any time contact the Plan Administrator. The Notice is also posted on the Plan Sponsor's intranet site. Even if you have agreed to receive this Notice electronically, you are still entitled to a paper copy of this Notice.

F. A Note About Personal Representatives

You may exercise your rights through a personal representative. Your personal representative will be required to produce evidence of his/her authority to act on your behalf before that person will be given access to your PHI or allowed to take any action for you. Proof of such authority may take one of the following forms:

- a power of attorney for health care purposes, notarized by a notary public;
- a court order of appointment of the person as the conservator or guardian of the individual; or
- an individual who is the parent of a minor child.

The Plan retains discretion to deny access to your PHI to a personal representative to provide protection to those vulnerable people who depend on others to exercise their rights under these rules and who may be subject to abuse or neglect. This also applies to personal representatives of minors.

Section 4: Notice of Breaches of Unsecured PHI

Under HIPAA, the Plan and its business associates, are required to maintain the privacy and security of your PHI. The goal of the Plan and its business associates is to not allow any

unauthorized uses or disclosures of your PHI. However, regrettably, sometimes an unauthorized use or disclosure of your PHI occurs. These incidents are referred to as "breaches." If a breach affects you and is related to unencrypted PHI, the Plan or its applicable business associate will notify you of the breach and the actions taken by the Plan or the business associate to mitigate or eliminate the exposure to you.

Section 5. Your Right to File a Complaint with the Plan or the HHS Secretary

If you believe that your privacy rights have been violated, you may complain to the Plan in care of the Plan Administrator. You may file a complaint with the Secretary of the U.S. Department of Health and Human Services, Hubert H. Humphrey Building, 200 Independence Avenue S.W., Washington, D.C. 20201. The Plan will not retaliate against you for filing a complaint.

Section 6. Whom to Contact at the Plan for More Information

If you have any questions regarding this Notice or the subjects addressed in it, you may contact the Plan Administrator.

Section 7. Conclusion

PHI use and disclosure by the Plan is regulated by a federal law known as HIPAA (the Health Insurance Portability and Accountability Act). You may find these rules at 45 *Code of Federal Regulations* Parts 160 and 164. This Notice attempts to summarize the regulations. The regulations will supersede any discrepancy between the information in this Notice and the regulations.

If you wish to exercise one or more of the rights listed in this Notice, contact the Plan Administrator.

Continuing Plan Coverage (COBRA)

You have limited continuing coverage rights under the Plan. All materials describing your rights under COBRA will be provided by the Third Party Administrator.

PART IV ADMINISTRATIVE PROVISIONS

Plan Administrator. The Plan Administrator shall be responsible for the performance of all reporting and disclosure obligations under ERISA, and all other obligations required to be performed by the plan administrator under ERISA or the Code, except such obligations and responsibilities as may be delegated under the Plan. The Plan Administrator shall be the designated agent for service of legal process with respect to the Plan.

1.2 Duties of the Plan Administrator.

- (a) The Plan Administrator shall have the sole discretion and authority to control and manage the operation and administration of the Plan.
- (b) The Plan Administrator shall have complete discretion to interpret the provisions of the Plan, make findings of fact, correct errors, supply omissions, and determine the benefits payable under this Plan. All decisions and interpretations of the Plan Administrator made in good faith pursuant to the Plan shall be final, conclusive and binding on all persons, subject only to the claims procedure, and may not be overturned unless found by a court to be arbitrary and capricious.
- (c) Plan Administrator shall have all other powers necessary or desirable to administer the Plan, including, but not limited to, the following:
 - (1) To prescribe procedures to be followed by Participants in making elections under the Plan and in filing claims under the Plan;
 - (2) To prepare and distribute information explaining the Plan to Participants;
 - (3) To receive from Participants and Dependents such information as shall be necessary for the proper administration of the Plan;
 - (4) To keep records of elections, claims, and disbursements for claims under the Plan, and any other information required by ERISA or the Code;
 - (5) To appoint individuals or committees to assist in the administration of the Plan and to engage any other agents as it deems advisable;
 - (6) To accept, modify or reject Participant elections under the Plan;
 - (7) To promulgate election forms and claims forms to be used by Participants, which may be electronic in nature;
 - (8) To determine and enforce any limits on benefit elections hereunder; and
 - (9) To correct errors and make equitable adjustments for mistakes made in the administration of the Plan, specifically, and without limitation, to recover erroneous overpayments made by the Plan to a Participant or Eligible Dependent, in whatever manner the Plan Administrator deems appropriate,

including suspensions or recoupment of, or offsets against, future payments due that Participant or Eligible Dependent.

1.3 Allocation and Delegation of Duties.

- (a) The Plan Administrator shall have the authority to allocate or delegate, from time to time, all or any part of its responsibilities under the Plan to one or more of its employees or the Third-Party Administrator. In the exercise of such allocated or delegated responsibilities, any action of the employee or Third-Party Administrator to whom responsibilities are allocated shall have the same force and effect for all purposes hereunder as if such action had been taken by the Plan Administrator. The employee or Third-Party Administrator to whom responsibilities have been allocated or delegated shall periodically report to the Plan Administrator concerning the discharge of the allocated or delegated responsibilities.
- (b) The Plan Administrator may employ such legal counsel, accountants, consultants, actuaries, and other agents as it shall deem advisable. The compensation of such legal counsel, accountants, consultants, actuaries and other agents and any other expenses incurred by the Plan Administrator in the administration or management of the Plan or in furtherance of its duties hereunder shall be paid by the Sponsor.
- **1.4 Bonding**. The Plan Administrator, each person who is a fiduciary under the Plan and each person who handles funds of the Plan, shall be bonded in an amount no less than the amounts required by ERISA Section 412 and the regulations issued thereunder.
- **1.5 Information to be Supplied by Sponsor**. Sponsor shall provide the Plan Administrator or its delegate with such information as it shall from time to time need in the discharge of its duties. The Plan Administrator may rely conclusively on the information certified to it by the Sponsor.
- 1.6 Nondiscriminatory Operation. All rules, decisions, interpretations and designations by the Plan Administrator under the Plan shall be made in a nondiscriminatory manner, and persons similarly situated shall be treated alike. The Plan Administrator may limit, reallocate or deny any benefit to any Participant who was a highly compensated individual (as defined in Code Section 105(h)) to the extent necessary to avoid discrimination under Code Section 105(h).

PART V – REQUIRED NOTICES

The Plan may not restrict benefits for any hospital length of stay in connection with childbirth for the mother or newborn child to less than forty-eight (48) hours following a normal vaginal delivery, or less than ninety-six (96) hours following a cesarean section, or require that a provider obtain authorization from the Plan or the insurance issuer for prescribing a length of stay not in excess of the above periods.

To the extent the Plan provides benefits with respect to mastectomy, it will provide, in the case of an individual who is receiving benefits in connection with a mastectomy and who elects reconstruction in connection with such mastectomy, coverage for all stages of reconstruction of the breast on which a mastectomy was performed, surgery and reconstruction of the other breast to provide a symmetrical appearance, prostheses, and coverage of physical complications at all stages of the mastectomy, including lymphedemas.

PLAN TERMS

- 1.1 Eligible Flight Attendant: Eligible Flight Attendant means:
 - (a) A former employee of the Company who upon termination was employed as a Flight Attendant and who has satisfied the following requirements as of his or her termination:
 - (1) Completed 30 or more Years of Service as a Flight Attendant,
 - (2) Has a Termination date between January 1, 2017 and April 2, 2025; and
 - (3) Was not terminated for cause.

1.2 <u>Dependent; Eligible Dependent:</u>

A Dependent includes a child (as defined in Code Section 152(f)(1)) of the Participant until the date of the child's 27th birthday.

In addition, a Dependent includes any individual who, at the date of the Participant's retirement from the Employer, is a dependent of the Participant within the meaning of Code Section 152, determined without regard to subsections (b)(1), (b)(2) and (d)(1)(B) thereof.

<u>Eligible Dependent</u>: A Dependent or a Spouse may be an Eligible Dependent only if and when the Eligible Flight Attendant becomes a Participant.

- 1.3 <u>Benefit Credit</u>: The following amounts, based on Years of Service, will be credited to the HRA Account of a Participant with
 - (a) Thirty to Thirty-Five Years of Service: \$10,000
 - (b) More than Thirty-Five Years of Service up to Forty Years of Service: \$20,000
 - (c) More than Forty Years of Service: \$30,000

1.4 Account Structure:

Separate Accounts. A separate HRA Account will be established for each Participant and each such Participant's Benefit Credits as noted in Section 1.10 will be credited to his/her separate HRA Account.

1.5 <u>Timing of Credit</u>: Benefit Credit specified in Section 1.3 will be credited to HRA Accounts as follows:

One time on the Enrollment Date or as soon as practicable thereafter.

1.6 Years of Service: A Years of Service is determined by the amount of time an Eligible Flight Attendant is employed by the Employer as a Flight Attendant. One Year of Service is equal to twelve (12) months. A Flight Attendant will receive Years of Service credit for the entire month in which she/he separates from the Employer. The seniority date that is used to determine Years of Service will be the ORIGINAL SENIORITY DATE on the Flight Attendant System Seniority List, which is attached as Exhibit A.

1.7 <u>Catastrophic Coverage Reimbursement</u>: Participants and/or Eligible Dependent and Spouses shall receive Catastrophic Coverage Reimbursement for qualifying prescription drug expenses. This coverage will begin only after the Participant incurs the following qualifying prescription drug expenses for the applicable Plan Year:

After the Participant has accumulated covered Part D expenses in an amount equal to the true out of pocket (TrOOP) limit set by CMS for the applicable Plan Year. Thereafter, eligible claims for qualifying prescription drug expenses will be reimbursed for the remainder of the applicable Plan Year subject to available funds in the HRA Account.
